REGULAR MEETING JUNE 9, 2016

The Hamlin Township Board met Thursday, June 9, 2016 at 6:00 p.m. at the Hamlin Townhall. Present: Vandervest, Lewis, Ptaszenski, Gurzynski, Rees. Absent: None. Approximately 9 people in attendance.

Ms. Vandervest called the meeting to order and led the Pledge to the Flag.

On the MOTION of Rees, supported by Ptaszenski, the Board approved the June 9, 2016 as presented.

### **Comments from the Floor**:

- 1) Dave Dister, N. Lakeshore Drive, is a biologist who is concerned with some invasive plants in Hamlin Lake, specifically the garlic mustard plant and wanted to distribute information to the Township to be better prepared. He passed out a handout which can be scanned on either side to be put on our website. He explained that this plant was brought in to North America in the late 1800's and in Michigan in the last thirty years. It has been carried in from the south through campers with trailers as the seeds are carried on the wheel treads and people's shoes with treads. It is a fast growing plant and travels pretty fast because people travel around. It grows in forest areas, especially damp areas. In Hamlin Township, four/five years ago, he found it on Jagger Road which he feels it could have traveled during the road improvements. It is a very nasty, dominant plant and he doesn't want to see it take over areas. The worst area in Hamlin is the Long Skinny Park. A large amount has also been found from the north edge of Tamarac Village all the way up to the South Bayou. Just recently, he has been seeing it on the north end of the Township along the Barnhart Road area, so it is spreading fast. He is encouraging anyone to contact him with any questions or contact the Mason-Lake Conservation District. It is very hard to destroy once it starts the budding process. It is best to pull the plant in its first year. For further information on how to handle this plant and what to look for, contact Dave Dister at david.dister@gmail.com or (231) 845-7574. The information will also be placed on our website.
- 2) Jim Galley, Manager at the Ludington State Park, also spoke about the garlic mustard plant issue and indicated it is addressed at the State Park. It is found in quite a few areas along Piney Ridge Road either spread by yard waste or by work on the roads. He has a group that has been working on the Piney Ridge Road area for the last three/four years and has finally starting to get the patches a little smaller, but it doesn't take much for it to spread. Along with contacting the Mason-Lake Conservation District that Dave mentioned, he encourages any resident that is aware of this plant on their property to also contact the State Park. There is also an invasive species management area that involves counties including Mason, Lake, and Oceana that record where all the infected areas are and then use grant funding to help treat these areas and also use volunteers to help treat the areas in private properties as well.
- 3) Jim/Carol Maddux, Duneview Drive, own the house next to the property the Township purchased to build a parking lot. Mr. Maddux stated that even though the parking lot has not been built yet, people are using it to pull in their trailers, cars, etc. He distributed the letter they wrote last year regarding the possibility of placing a fence or a row of closely spaced trees to protect his privacy and passed out a new letter and two quotes for fence prices for the Board to review.

On the **MOTION** of Ptaszenski, supported by Gurzynski, the minutes of the May 12, 2016 meeting were approved as written.

Armstrong indicated that he had not realized that in the last 30 years we are the only summer school district to collect taxes and that has been balanced.

Granting the requested variance would allow the Kyriakou's to construct an addition to an existing single family dwelling within nine (9) feet of their east property line. Section 5.02 of Ordinance No. 45 requires a side line setback of twelve (12) feet. Variance requested three (3) feet. Hamlin Township Zoning Ordinance 45, Section 5.02, requires a road setback of twenty-five (25) feet. Variance requested: Eight (8) feet. The Lovato's property is further identified as the Plat of Bugg's Point, Lots 3 and 4, Section 2, T19N R18W. Parcel ID #53-007-180-003-00.

\*Mr/Mrs. Timothy J. Trapp, owners of property located at 3774 N. Lakeshore Drive, Hamlin Township, Mason County, MI are seeking relief from a certain section of Hamlin Township Zoning Ordinance No. 45 now in effect. The Trapp's are requesting a variance to reconstruct a deck with steps, demolish without a permit, to within twenty-one (21) feet of the established right-of-way of N. Lakeshore Drive. Hamlin Township Zoning Ordinance 45, Section 5.02, requires a road setback of twenty-five (25) feet. Variance requested: Four (4) feet. The Trapp's property is further identified as Hamlin Lake Resort, the north 50' of Block 41 known as Lot 4; and, the entire vacated 8<sup>th</sup> Street lying between the east line of Lakeshore Drive and the west line of Front Street, Section 2 T19N R18W. Parcel ID #53-007-280-254-00.

#### **Transfer Facility:**

- 1) **Summer Hours**: Began May 1, 2016 and will run until September 30, 2016 Hours: Monday, Wednesday & Saturday 10 a.m. to 6 p.m.
- 2) The 2016-2017 Recycling Stickers are available. The yearly recycling sticker recycling is good from April 1<sup>st</sup> through March 31<sup>st</sup>, which is the Township's fiscal year. Cost is \$15 for residents and \$50 for non-residents. The 2016-2017 sticker color is orange and includes the year on them.
- 3) 13-gallon size purple Township garbage bags can be purchased for \$5 for 10 bags. 30-gallon size green Township garbage bags can be purchased for \$11 for 10 bags.
- 4) <u>Clean-Up Day</u> is scheduled for Saturday, June 18, 2016 from 8 a.m. to 12 noon. Property owners must secure a free voucher prior to 4:30 p.m. on June 17, 2016 from the Hamlin Township Office. Vouchers are now available 6
- 5) <u>Tire Recycling/Collection Day</u> is scheduled for August 6, 2016 to be held at the Hamlin Township Transfer Facility. Property owners must secure a free voucher. Vouchers are now available -20 vouchers issued to date.
- 6) <u>Household Hazardous Waste Collection Day</u> is scheduled for Saturday, August 15, 2016 from 9 a.m. to 3:00 p.m. at the Mason County Road Commission in Scottville. This service is free to Hamlin Township property owners. Be prepared to show I.D. No voucher required. Old, unwanted, out of date, or unusable pesticides can be dropped off along with cleaners, paint, automotive and fuel products.

# **Mason County Sheriff's Department:**

1) Sheriff Kim Cole thanked the Board for the use of our hall during the Joe Lancour dedication. It went very well with close to 100 people in attendance and the signs are now up on both sides. He presented the Sheriff's report for May, 2016 noting there were 30 calls for service which included 3 traffic crashes. They picked up one drugged driver and three drunk drivers and did get one up in the subdivision we talked about last month. The Sheriff presented a Marine Patrol Report for May indicating 22.5 hours were spent on Hamlin Lake. Sheriff Cole also handed out the Mason County annual report on traffic crashes county-wide. You can also access their website which is open to the public at Michigan Traffic Crash Facts. Sheriff Cole went on this website and pulled off crashed in Hamlin Township that occurred in 2015. He stated there were 93 crashes in 2015 – 54 car/deer; 2 drunk driving; and, 6 injury crashes; and, where we were much higher than other counties was in older driver crashes. There were 12 crashes occurring with drivers between 60-64 years of age; 9 crashes between drivers 65-74 years of age; and, 6 crashes of drivers 75-80 years of age. This is above the norm for our county. It might not be all Hamlin residents however. Sheriff Cole noted that in 2014, there were 77 crashes, one fatal with 2 fatalities and 7 injury crashes injuring 14 people. He also mentioned that his dept. can take this information found in this report and use it to find out where accidents seem to be happening and adjust their patrols accordingly. They can also pull whether the crashes was based on speed or if it was a head-on crash because someone tried to beat the light and hit a car that was in the turn lane waiting to turn left. That is what was found to be happening on US 10 between Ludington and Scottville where people were trying to beat the light and another car turned left in front of them so they adjusted their patrols accordingly. Sheriff Cole had been a crash re-constructionist for ten years before becoming the Sheriff and finds this very interesting. He indicated we can either make copies of this report or anyone can go on to the website and search the information for ourselves. The site includes a wide variety of information for anyone interested. N. Vandervest asked about the "No Wake" sign that Nancy had mentioned to them that was in the water by Indian Pete Bayou. A resident told her that it is almost all the way under water. Sheriff Cole indicated that he sent someone out there and he said he saw the sign, it is upright, and visible; but, he will have him check it out again.

#### Parks:

- 1) Completed Projects:
- \*Picnic tables have been placed at the various parks;
- \*New "Rules" signs have been installed at the Wilson Hill Park as well as the South Bayou Park;
- \*Stone has been added to the side of the launch pad at the South Bayou Park.
- \*Installed hand pump at Wilson Hill Park.
- 2) Projects to be Completed:
- \*Install plywood on the seawall at the Long Skinny Park fill the areas with large field stone;
- \*Repair bumpers on the dock at Wilson Hill Park.
- 3) Grant application to Great Lakes Energy for assistance with the Duneview Drive parking area was submitted on 5/16/16.
- 4) Received \$22 from the donation box at the South Bayou Park.

#### **Roads:**

- 2) South Bayou Bridge project is complete and the road was re-opened on 5/20/16.
